Essential Qualifications

1. M.Sc. in Agricultural Statistics/ Statistics/ Applied Statistics/ Computer Applications/Information Technology/ M.Tech./ MCA or equivalent with 4 years or 5 years of Bachelor's degree
2. Candidates having Master's degree in basic sciences with 3 years Bachelor's degree and two years Master's degree should have NET qualification or Ph.D. in any of the above disciplines

Desirable Qualifications

- Working experience in the area of statistical designs for product optimization
- Experience in development of software, mobile app and web solutions etc.
- Working knowledge and experience on statistical software like SAS, R and MATLAB.

Duration: 8 months (approximately)

Emoluments: Rs.31,000/- per month + 16% HRA.

Age Limit: Age for JRF should be not more than 35 years (5 years relaxation for SC/ST/women candidates and 3 years for OBC candidates) as on the date of the interview.
