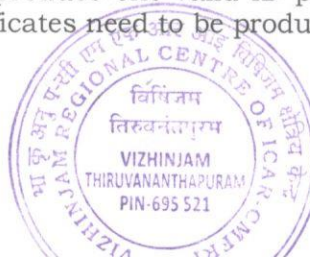
**Walk-in-Interview for the post of Field staff**

In case of more applicants, applications will be screened based on qualifications and/experience and short listed.** Shortlisted candidates will be intimated by e-mail, and only those who receive communication may appear for the interview on the specified date and time.
