The eligible candidates must bring all the original documents and a filled biodata for verification to attend the walk-in interview on the specified date and time. Essential Qualification	:	Graduates in the discipline of Fisheries Science/ Zoology or related subjects.
Desirable experiences	:	Experience in marine fishery field data collection and knowledge in identification marine fishes; Good working knowledge in computer, online data entry and operation of tab/ phone.
Age	:	The minimum age will be 21 and the maximum 45 years (age relaxation applicable for OBC/SC/ST candidates as per GOI norms).
Nature & Duration of post	:	Purely on temporary basis for a period of one year and likely to be extended as per ICAR guidelines
Emoluments	:	Rs.30,000/-per month (Consolidated Emoluments as per revised ICAR guidelines)

General terms & conditions:-

1. The applicant must bring all the original documents and the biota for verification during the interview. Candidates should produce one valid ID proof at the time of the interview.
2. Eligible candidates for the above contractual position will be interviewed at the Committee Hall, ICAR-Tuticorin Regional Station of CMFRI, Thoothukudi-1.
3. Only passed-out graduates are eligible to apply. Candidates awaiting the result are not qualified and need not apply.
4. The crucial date for determining the age limit shall be the interview date.
5. For SC/ST candidates, an age relaxation of five years and three years for OBC candidates will be given as per the Govt. of India/ICAR rules.
6. The above position is purely temporary. The appointment will be co-terminus with the project's termination. Other terms and conditions will be as per the revised ICAR guidelines for recruiting Young Professionals and Field Assistants in ICAR.
7. The selected candidate will have no right whatsoever for absorption/regularization in the institute.
8. The selection of candidates does not entail any right for absorption/ regularization at CMFRI.
